I or my legal representative, if any, am aware that by participating in the above mentioned event/sporting event, my physical integrity may be endangered - also with regard to an infection with the COVID-19 virus. I have weighed up this risk and expressly accept this by participating in the event. Furthermore, I also waive to this extent any claims for compensation against the organizer in the event of such an infection, unless these or the persons attributable to them act with intent or gross negligence.

I confirm that I have been informed that due to the COVID-19 regulations there will be no on-site athlete briefing on the day of the competition and that I am responsible for reading the online athlete briefing provided by the organizer prior to the event.

I, as a participant, expressly acknowledge that I am complying with the laws, regulations, guidelines and decrees issued for the above-mentioned event in compliance with the provisions for overcoming the Corona crisis and confirm that I am aware of all these legal provisions. Furthermore, by entering the entire event/sports facility during my stay, I undertake to comply with the legal provisions or any house rules and the general regulations of the federal sports federation responsible for the type of sport performed, as well as all guidelines and guidelines and recommendations issued by the federal sports federation responsible in connection with the Corona crisis.

I acknowledge that the operator of the sports facility or organizer is entitled to monitor compliance with the above-mentioned regulations. Furthermore, I undertake to immediately follow any instructions given by the operator of the sports facility or the organizer or their commissioned third parties to comply with the above regulations. Otherwise, they can also issue a reprimand from the event or exclusion from the competition. I must also immediately follow any reprimand or exclusion.

I confirm that I am not knowingly infected with the COVID-19 virus or have been in contact with any person infected in any way or have not been in a COVID-19 risk area within the last 14 days before the start of the event. Furthermore, I confirm that I have not been in quarantine (even only domestic quarantine) due to such a stay or due to contact with an infected person or that I am currently in quarantine and that I do not belong to one of the risk groups according to the regulations in connection with the management of the Corona crisis.

In case of non-compliance with the COVID-19 regulations or a violation of the content of this declaration of consent by me, I am liable to the operator of the sports facility or the organizer. I expressly agree to indemnify and hold harmless them in the event of claims by third parties based on a violation of this declaration of consent by my participation in the event, my stay and/or my behavior on the entire event area for any reason whatsoever.

I agree that photos and video material taken by me during events at the Hotel Mohrenwirt can be published and passed on to third parties and that I cannot derive any claims from this.

I can revoke my consent to publication in writing at any time. This revocation then applies to all future publications, but not to publications that have already taken place.

I am aware that this consent is voluntary and can be revoked at any time.
